CERTIFICATE OF LOCATION

LODE CLAIM

THIS IS TO CERTIFY that the CT #231 lode mining claim was located by:

corner of this claim.

We (or I) claim 1500 linear feet along the course of the ledge, lode or vein,
extending 1490 feet from the location monument in a Northerly direction
