CERTIFICATE OF LOCATION

LODE CLAIM

thence 5500 feet North and 1800 feet East to the Northeast
corner of this claim.

We (or I) claim 1500 linear feet along the course of the ledge, lode or vein,
extending 1490 feet from the location monument in a Northerly direction
