CERTIFICATE OF LOCATION

LODE CLAIM

THIS IS TO CERTIFY that the CT # 236 lode mining claim was located by:

SE/4 of Sec. 28, Twp. 35 North, Range 51 East.  
NW/4 of Sec. 34, Twp. 35 North, Range 51 East.  
SW/4 of Sec.       , Twp.        North, Range        East.

To tie this claim to the Public Survey, begin at the Southeast corner of Section  
33, Township 35 North, Range 51 East, Mount Diablo Meridian,  
thence 5500 feet North and 600 feet East to the Northeast  
corner of this claim.

We (or I) claim 1500 linear feet along the course of the ledge, lode or vein,  
extending 1490 feet from the location monument in a Northerly direction  
and 10 feet in a Southerly direction, together with 300 feet  
on each side of the center of the ledge for the entire length of the claim.
