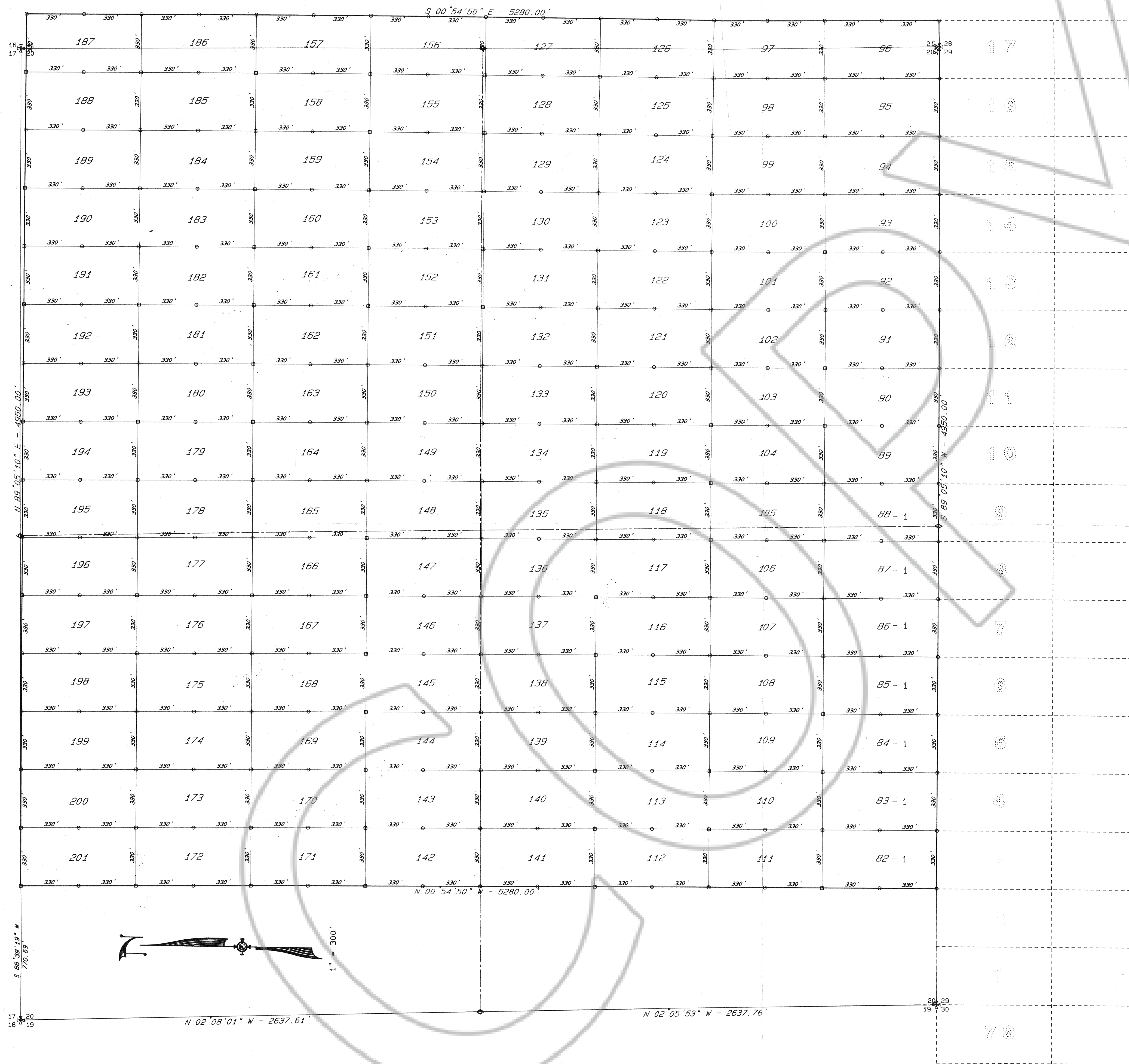




BASIS OF BEARINGS:

- SET 4"x4" WOOD POST WITH ALUMINUM TAG

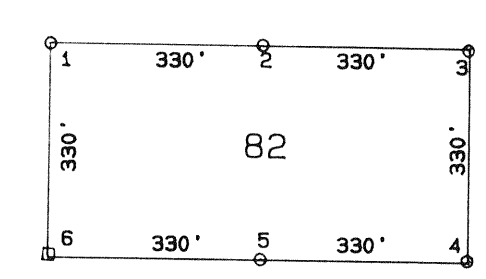
