ASSIGNMENT

THAT, ALFORD OIL CORPORATION, a Texas Corporation, hereinafter referred to as Assignor, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged and confessed, without warranty of title, expressed or implied, and subject to the reservations, conditions, and covenant provided for herein, does hereby GRANT, BARGAIN, SELL, TRANSFER, ASSIGN AND CONVEY unto William B. Daniel, III, whose mailing address is 8007 N. Bridge Circle, Spring, 77379, hereinafter referred to as "Assignee", 1.25% of 8/8 working interest with a net revenue interest of 0.9375% of all right, title and interest in and to the leases and interests hereinafter referred to as "Said Leases" described on Exhibit "A" attached hereto and made a part hereof, INSOFAR as Said Leases and interests cover the land described on Exhibit "A", together with a like interest in any acreage not listed on Exhibit "A", but is listed on Schedule VI attached to the Farmout Agreement dated March 13, 1987, between Foreland Corporation and Alford Oil Corporation, of which this Assignment is made subject to and together with all rights and privileges thereunder or appurtenant thereto. The leasehold interest assigned is hereinafter referred to as "Assigned Interest".

This Assignment is made and accepted and Assignee hereby assumes any or all royalties, overriding royalties, payments out of production, and other burdens or encumbrances to which Said Leases may be subject, INSOFAR as such royalties, overriding royalties, payments out of production or other burdens and encumbrances cover and effect the Assigned Interest.

This Assignment of all rights, reservations, and covenants in connection herewith, shall be considered covenants running with the land and shall inure to be binding upon the parties thereto, their heirs, personal representatives, successors and assigns; PROVIDED HOWEVER, no transfer or encumbrances of any of the Assigned Interests shall be made unless the same be made expressly subject to this Assignment and unless the vendee, assignee or transferee shall assume

all of the obligations of this Assignment. If the leases herein assigned are less than the full and undivided leasehold estate in and to the lands hereinabove described, then the interest herein assigned shall be reduced proportionally to correspond to the proportion that the leasehold interest bears to the whole or undivided fee.

TO HAVE AND TO HOLD said Assigned Interest unto assignee, assignee's heirs, successors, personal representatives and assigns subject to all of the expressed and implied covenants and obligations of Said Lease and this instrument.
