## ADMINISTRATIX'S DEED

This deed made and entered into this 12thay of May 1988, by and between GENEVA H. BISONI of 1403 Satellite Drive, Sparks, Nevada 89431 herein referred to and acting as the administratrix of the estate of LOUIS CHESTER BISONI, deceased, and VIOLET L. The parties recite and declare that:
