# CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that ATLAS PRECIOUS METALS INC.,  
by its Agent, the undersigned, does hereby locate the OLD YELLER 75  
Lode Mining Claim on this 19th day of April, 1988, situated in the  
Unknown Mining District, Eureka County, Nevada.

Thence, 750 feet in a west direction to Post No. 4, marked -OLD YELLER 75-4  
Thence, 600 feet in a north direction to Post No. 5, marked -OLD YELLER 75-5  
Thence, 750 feet in a east direction to Post No. 6, marked -OLD YELLER 75-6  
Thence, 750 feet in a east direction to Post No. 1, marked -OLD YELLER 75-1

the point of beginning and all posts being 4" wood post or cut and marked trees  
or 3" x 4" durable plastic pipe.

The number of linear feet claimed in length along the course of the vein from the  
point of discovery is 1490 feet in a east direction and 10 feet in a  
west direction, together with 300 feet on each side of the center of the  
vein or lode for the entire length of the claim.

The general course of the vein or lode is east and west.
