CERTIFICATE OF LOCATION - NEVADA

The number of near feet claimed in length along the course of the vein from the point of discovery is 10 feet in a east direction and 1490 feet in a west direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

The general course of the vein or lode is east and west.

The work of location consisted of making the maps as provided in NRS 517.040. Dated May 9th A.D., 1988, and filed in duplicate.

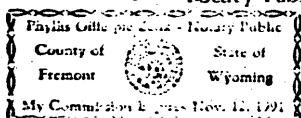
