CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that ATLAS PRECIOUS METALS INC., by its Agent, the undersigned, does hereby locate the OLD YELLER 80 Lode Mining Claim on this 19th day of April, 1988, situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the NE (Quarter) Section(s) 14 Township 19 North, Range 52 East, Mt. Diablo P.M., and is more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1,

The number of linear feet claimed in length along the course of the vein from the point of discovery is 10 feet in a east direction and 1490 feet in a west direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.
