CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that ATLAS PRECIOUS METALS INC., by its Agent, the undersigned, does hereby locate the OLD YELLER 83 Lode Mining Claim on this 19th day of April, 1988, situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the NE(NW)(SE)(SW) (Quarter) Section(s) 14(13)(14)(13), Township 19 North, Range 52 East, Mt. Diablo P.M., and is more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1,

- Thence, 600 feet in a south direction to Post No. 2, marked OLD YELLER 83 -2
- Thence, 750 feet in a west direction to Post No. 3, marked OLD YELLER 83 -3
- Thence, 750 feet in a west direction to Post No. 4, marked OLD YELLER 83 -4
- Thence, 600 feet in a north direction to Post No. 5, marked OLD YELLER 83 -5
- Thence, 750 feet in a east direction to Post No. 6, marked OLD YELLER 83 -6
- Thence, 750 feet in a east direction to Post No. 1, marked OLD YELLER 83 -1

the point of beginning and all posts being 4" wood post or cut and marked trees or 3" x 4" durable plastic pipe.

The number of linear feet claimed in length along the course of the vein from the point of discovery is 1490 feet in a east direction and 10 feet in a west direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

The general course of the vein or lode is east and west.

To tie this Claim to the Public Survey, begin at the Northwest corner, Section 27, Township 20 N., Range 52 E., Mt. Diablo P.M., and bear south, 20800 feet and east, 9600 feet to the northeast corner of this Claim.
