CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that ATLAS PRECIOUS METALS INC., by its Agent, the undersigned, does hereby locate the OLD YELLER 84 Lode Mining Claim on this 19th day of April, 1988, situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the SE (Quarter) Section(s) 14, Township 19 North, Range 52 East, Mt. Diablo P.M., and is more particularly described as follows, to wit:
