CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that ATLAS PRECIOUS METALS INC., by its Agent, the undersigned, does hereby locate the OLD YELLER 100 Lode Mining Claim on this 20th day of April, 1988, situated in the Unknown Mining District, Eureka County, Nevada.
