No. 5: <u>NE Corner</u>	<u>NE COR LJC-3</u>	<u>5' long X 4" diameter PVC pipe.</u>
No. 6: <u>E Side Center</u>	<u>ESC LJC-3</u>	<u>5' long X 4" diameter PVC pipe.</u>

As erected on the ground, each side center or corner monument is marked as described above by metal tags (e.g. metal tags, paint on posts).

The work of location consisted of making a claim map as provided in NRS 517.040.
