### CERTIFICATE OF LOCATION - MILL SITE - NEVADA

THE UNDERSIGNED, hereby certifies that ATLAS PRECIOUS METALS INC., by its Agent, the undersigned, does hereby locate the AM 212 Mill Site Claim on the 23rd day of April, 1988, situated in the Unknown Mining District, Eureka County, Nevada.

Thence, 363 feet in a <u>N45°40'E</u> direction to Post No. 1, marked -	<u>AM 212</u>	<u>-1</u>

the point of beginning, containing 5.00 acres, with all posts being 3 1/2" or 4" x 4" or 4 1/2" wood posts.

The notice of location is posted on the most westerly corner No. 6.

The name of the mine of which ATLAS PRECIOUS METALS INC. is the proprietor is the Goldbar Mine.

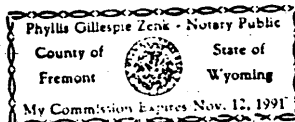
