CERTIFICATE OF LOCATION - MILL SITE - NEVADA

THE UNDERSIGNED, hereby certifies that ATLAS PRECIOUS METALS INC., by its Agent, the undersigned, does hereby locate the AM 214 Mill Site Claim on the 23rd day of April, 1988, situated in the Unknown Mining District, Eureka County, Nevada.
