CERTIFICATE OF LOCATION - MILL SITE - NEVADA

THE UNDERSIGNED, hereby certifies that ATLAS PRECIOUS METALS INC., by its Agent, the undersigned, does hereby locate the AM 216 Mill Site Claim on the 23rd day of April, 1988, situated in the Unknown Mining District, Eureka County, Nevada.

Said claim is located in the SE Quarter, Section 28, Township 22 North, Range 49 East, Mt. Diablo P.M. and more particularly described as follows, to wit:

Thence, <u>300</u> feet in a <u>N44°20'W</u> direction to Post No. 6, marked - <u>AM 216</u>	<u>-6</u>
Thence, <u>363</u> feet in a <u>N45°40'E</u> direction to Post No. 1, marked - <u>AM 216</u>	<u>-1</u>

the point of beginning, containing 5.00 acres, with all posts being 3 1/2" or 4" x 4" or 4 1/2" wood posts.

The notice of location is posted on the most northerly corner No. 1.

The name of the mine of which ATLAS PRECIOUS METALS INC. is the proprietor is the Goldbar Mine.

To tie this Claim to the Public Survey,* begin at the Northeast corner, Section 27, Township 22 N., Range 49 E., Mt. Diablo P.M., bear S45°40'W, 6892 feet and N44°20'W, 2653 feet to the corner post No. 1 of this claim.

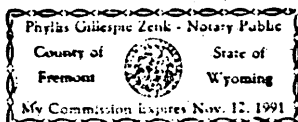
