# CERTIFICATE OF LOCATION - NEVADA

The number of linear feet claimed in length along the course of the vein from the point of discovery is 200 feet in a S89°46'E direction and 1250 feet in a N89°46'W direction, together with 15 feet on each side of the center of the vein or lode for the entire length of the claim.

The general course of the vein or lode is N89°46'W and S89°46'E.
