CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that ATLAS PRECIOUS METALS INC., by its Agent, the undersigned, does hereby locate the WI 170A Lode Mining Claim on this 2nd day of May, 1988, situated in the Unknown Mining District, Eureka County, Nevada.
