14 The verified Petition of the Executrix praying that an
15 Attorneys' Contingent Fee Compensation Agreement, entered into
16 between the Estate and the attorneys therein, be approved in
17 accordance with N.R.S. 150.060 having come on regularly to be
18 heard on the 3rd day of June, 1988, and the duly-appointed
19 Executrix being present in Court and being represented by Charles
20 M. Murphy, her attorney, and due proof having been made to the
21 satisfaction of this Court that notice to all persons as required
22 by law has been duly given and proof thereof filed with the Clerk
23 of the Court, and evidence having been heard by the Court, and it
24 appearing that no objection to said Petition was made and that the
25 allegations of said Petition were and are true, and the Court
26 further finding that the Executrix, in order to fulfill her duty

1 to take possession of the real and personal property of the
2 Deceased and to maintain actions for the recovery of any real and
3 personal property and to use reasonable diligence in doing the
4 same is required to investigate and seek to secure possession of
5 monies and/or other assets constituting the undistributed assets
6 of DOROTHY H. SYMONS, the deceased mother of the above-named
7 decedent, and monies and properties administered under that
8 certain Declaration of Trust dated March 7, 1987; and that the
9 employment of attorneys to so represent the Estate would be
10 difficult and/or impossible, considering the limited availability
11 of funds and liquid assets to the Estate at this time, and the
12 Court further finding that the said Attorneys' Contingent Fee
13 Compensation Agreement is necessary to the proper administration
14 of the Estate and that the terms thereof are reasonable and in the
15 best interest of the Estate and those interested therein.

16 From said findings, the Court concludes that it has
17 jurisdiction over the Estate of the decedent and over this matter,
18 that the said Attorneys' Contingent Fee Compensation Agreement, a
19 copy of which is attached to the Petition on file herein, should
20 be approved and confirmed, and the Estate administration carried
21 forward in accordance therewith.

22 NOW, THEREFORE, IT IS HEREBY ORDERED, ADJUDGED AND
23 DECREED that the said Attorneys' Contingent Fee Compensation
24 Agreement dated March 25, 1988, should be, and it hereby is,
25 approved, ratified and confirmed in accordance with N.R.S. 150.060
