MOUNT DIABLO MERIDIAN, NEVADA. SAID CLAIM LIES WITHIN THE NW 1/4 Sec 35 and
SW 1/4 Sec 26, T24N, R50E, MDM. FROM THIS DISCOVERY MONUMENT, THE
UNDERSIGNED CLAIMS 20 FEET IN AN/AN N2°24'30"W DIRECTION, AND, 1480
FEET IN A/AN S2°24'30"E DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE
