THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 1620' (N6°E) FROM THE SOUTHWEST CORNER OF SECTION 26 TOWNSHIP 24N, RANGE 50E, MOUNT DIABLO MERIDIAN, NEVADA. SAID CLAIM LIES WITHIN THE SW 1/4 Sec 26 & SE 1/4 Sec 27 T24N, R50E, MDM. FROM THIS DISCOVERY MONUMENT, THE UNDERSIGNED CLAIMS 20 FEET IN AN/AN N2°24'30"W DIRECTION, AND, 1480 FEET IN A/AN S2°24'30"E DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
