SAID CLAIM LIES WITHIN THE SW 1/4 Sec 26 T24N, R50E, MDM. FROM THIS DISCOVERY MONUMENT, THE UNDERSIGNED CLAIMS 20 FEET IN AN/AN S2°24'30"E DIRECTION, AND, 1480 FEET IN A/AN N2°24'30"W DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
