CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that ATLAS PRECIOUS METALS INC., by its Agent, the undersigned, does hereby locate the OLD YELLER 129 Lode Mining Claim on this 17th day of June, 1988, situated in the Unknown Mining District, Eureka County, Nevada.
