THE UNDERSIGNED, hereby certifies that ATLAS PRECIOUS METALS INC., by its Agent, the undersigned, does hereby locate the OLD YELLER 131 Lode Mining Claim on this 13th day of June, 1988, situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the SW (Quarter) Section(s) 24 Township 19 North, Range 52 East, Mt. Diablo P.M., and is more particularly described as follows, to wit:

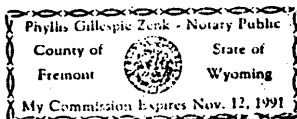
