Thence, 600 feet in a north direction to Post No. 5, marked -OLD YELLER 140 -5
Thence, 750 feet in a east direction to Post No. 6, marked -OLD YELLER 140 -6
Thence, 750 feet in a east direction to Post No. 1, marked -OLD YELLER 140 -1

the point of beginning and all posts being 3" x 4' durable plastic pipe.

The number of linear feet claimed in length along the course of the vein from the point of discovery is 1490 feet in a east direction and 10 feet in a west direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

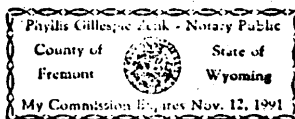
