THE UNDERSIGNED, hereby certifies that ATLAS PRECIOUS METALS INC., by its Agent, the undersigned, does hereby locate the OLD YELLER 144 Lode Mining Claim on this 12th day of June, 1988, situated in the Unknown Mining District, Eureka County, Nevada.
