CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that ATLAS PRECIOUS METALS INC., by its Agent, the undersigned, does hereby locate the AT 33 Lode Mining Claim on this 15th day of June, 1988, situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the SW(NW) (Quarter) Section(s) 18(19), Township 18 North, Range 53 East, Mt. Diablo P.M., and is more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1,

Thence, 750 feet in a south direction to Post No. 2, marked - AT 33 -2
Thence, 750 feet in a south direction to Post No. 3, marked - AT 33 -3
Thence, 600 feet in a west direction to Post No. 4, marked - AT 33 -4
Thence, 750 feet in a north direction to Post No. 5, marked - AT 33 -5
Thence, 750 feet in a north direction to Post No. 6, marked - AT 33 -6
Thence, 600 feet in a east direction to Post No. 1, marked - AT 33 -1

the point of beginning and all posts being 3" x 4" durable plastic pipe

The number of linear feet claimed in length along the course of the vein from the point of discovery is 10 feet in a north direction and 1490 feet in a south direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

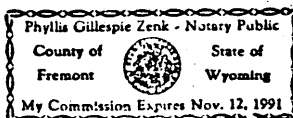
