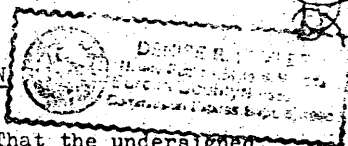

27 Box 117, Beowawe, Nevada.

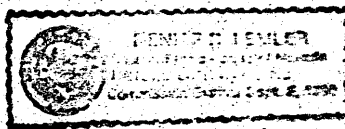
