The locator hereby claims 50 feet in an Easterly direction and 1450 feet in a Westerly direction from the location monument and 300 feet on each side of said lode or vein. The general course of this claim is East-West.

Within 20 days after posting notice on the ground, the locator defined the boundaries of the claim as required by law and established monuments consisting of 4 x 4 inch wooden posts, native timber, 4 inch diameter PVC pipe or rock monuments.
