The discovery monument is located approximately 900 feet in a SPE direction from the peak of Hornitos Cone, Eureka Co Nevada

Within 20 days after posting notice on the ground, the locator defined the boundaries of the claim as required by law and established monuments consisting of 4 x 4 inch wooden posts, native timber, 4 inch diameter PVC pipe or rock monuments. Each monument is marked with the name of the claim and a diagram or statement indicating its location.
