CERTIFICATE OF LOCATION

KNOW ALL MEN BY THESE PRESENTS, that FMC MINERALS CORPORATION, having an office and place of business at 5011 Meadowood Way, Suite 200, Reno, Nevada 89502, has located the SOL 261

lode mining claim this 16th day of June, 1988, under and by virtue of the mining laws and regulations of the United States and the State of Nevada.

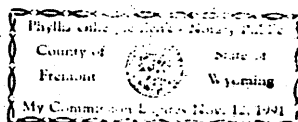
