CERTIFICATE OF LOCATION

BEFORE ME, the undersigned authority, on this 12th day of June, 1988, personally appeared FMC MINERALS CORPORATION, having an office and place of business at 5011 Meadowood Way, Suite 200, Reno, Nevada 89502, has located the SOL 333
