

## CERTIFICATE OF LOCATION

FROM ALL MEN BY THESE PRESENTS, that THE MINERALS CORPORATION, having an office and place of business at 5011 Meadowood Way, Suite 200, Reno, Nevada 89502, has located the Block 344

lode mining claim this 16th day of June, 1988, under and by virtue of the mining laws and regulations of the United States and the State of Nevada.

The number of linear feet claimed in length along the course of the vein from the point of discovery is 10 feet in N 45° W direction and 1490 feet in a S 45° E direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

To tie this claim to the Public Survey, begin at the Northeast Corner, Section 1, T. 19 N., R. 50 E., M.L. Diablo P.M., and bear S 45° E 11800 feet, and N 45° E 15800 feet, to the northeast corner of this claim.

The general course of strike of the vein or lode as near as may be determined is N 45° W and S 45° E.




