

CERTIFICATE OF LOCATION

KIM ALL MEN BY THESE PRESENTS, that THE MINERALS CORPORATION, having an office and place of business at 5011 Meadowood Way, Suite 200, Reno, Nevada 89507, has located the SOL 344

lode mining claim this 16th day of June, 1988, under and by virtue of the mining laws and regulations of the United States and the State of Nevada.

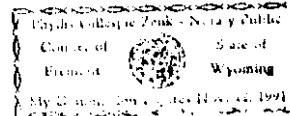
