CERTIFICATE OF LOCATION

BEFORE ALL, BEYOND THESE PRESENTS, that FMC MINERALS CORPORATION, having an office and place of business at 5011 Meadowood Way, Suite 200, Reno, Nevada 89502, has located the SOL 345

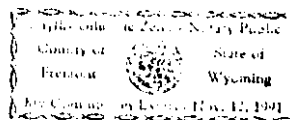
