CERTIFICATE OF LOCATION FOR LODE MINING CLAIM

- SE 1/4 of Section 6, Township 21 N., Range 51 E., M.D.B. & M.

To tie this claim to the Public Survey, begin at the Northeast Corner of Section 1, Township 21 North, Range 50 East, Mount Diablo Base and Meridian, thence South, approximately 2346 feet and East, approximately 2206 feet to the Northwest corner (Cor. No. 1) of this claim.

We (or I) claim 1,490 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 1,480 feet from the location monument in a Southerly direction and 10 feet in a Northerly direction, together with 295 feet on each side of the center of the ledge for the entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial 3 inch x 5 foot long plastic post monuments firmly set in the ground and bearing applicable monument designation. The description of such claim is:
