

## CERTIFICATE OF LOCATION

KNOW ALL MEN BY THESE PRESENTS, that FMC MINERALS CORPORATION, having an office and mailing address of 5011 Meadowood Way, Suite 200, Reno, Nevada, 89502, has located the
