## CERTIFICATE OF LOCATION

KNOW ALL MEN BY THESE PRESENTS, that FMC MINERALS CORPORATION, having an office and mailing address of 5011 Meadowood Way, Suite 200, Reno, Nevada, 89502, has located the

BASS 136

lode mining claim this 10th day of July, 1988, under and by the virtue of the mining laws and regulations of the United States and the State of Nevada.

The number of linear feet claimed in length along the course of the vein from the point of discovery is 1490 feet in a  $N30^{\circ}W$  direction and 10 feet in a  $S30^{\circ}E$  direction, together with 100 feet on each side of the center of the vein or lode for the entire length of the claim.
