NOTICE IS HEREBY GIVEN That the undersigned, having complied with the requirements of Chapter Six, Title thirty-two of the Revised Statutes of the United States, and the laws of the above State, and the local customs and regulations of said district,

has located and do hereby locate 1500 linear feet in length,

and 600 feet in width on the 1X 38

lode, vein, ledge or deposit (or placer ground), situated in above State, County or Mining District and further described as follows: Commencing at a post marked NE corner located about 300 feet east from the Monument of Location, thence

750 feet in a Southerly

direction to a post marked East Side center, thence 750 feet in a Southerly

direction to a corner post marked SE corner, thence 600 feet in a Westerly

direction to a corner post marked SW corner, thence 750 feet in a Northerly

direction to a post marked Westside center, thence 750 feet in a Northerly

direction to a corner post marked NW corner, thence 600 feet in a Easterly

direction to the NE corner hereby locating and intending to claim 1,450

feet in a Southerly direction from monument of location to the South

end line, and 50 feet in the opposite direction from discovery to the

North end line, and 300 feet on each side of the middle of
