has located and do hereby locate 1500 linear feet in length, and 600 feet in width on the 1X, 44

lode, vein, ledge or deposit (or placer ground), situated in above State, County or Mining District and further described as follows: Commencing at a post marked NE corner located about 300 feet east from the Monument of Location, thence 750 feet in a Southerly

direction to a post marked East Side center, thence 750 feet in a Southerly
