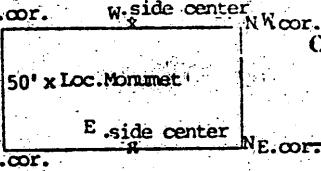

CERTIFICATE OF LOCATION

This diagram explains method of description of claim.

NOTICE IS HEREBY GIVEN That the undersigned, having complied with the requirements of Chapter Six, Title thirty-two of the Revised Statutes of the United States, and the laws of the above State, and the local customs and regulations of said district,

has located and do hereby locate 1500 linear feet in length, and 600 feet in width on the 1X 52

lode, vein, ledge or deposit (or placer ground), situated in above State, County or Mining District, and further specified as follows: Commencing at a post marked SE corner located about 300' east from the monument of location, thence 750 feet in a Northerly direction to a Eastside center post marked, thence 750 feet in a Northerly direction to a corner post marked NE corner, thence 600 feet in a Westerly direction to a corner post marked NW corner, thence 750 feet in a Southeasterly direction to a post marked Westside Center, thence 750 feet in a Southerly direction to a corner post marked SW corner, thence 600 feet in a Easterly direction to the SE corner hereby locating and intending to claim 1450 feet in a northerly direction from monument of location to the north end line, and 50 feet in the opposite direction from discovery to the south end line, and 300 feet on each side of the middle of said lode or ledge for the purpose of mining the same and claiming all surface rights, privileges and minerals, with all dips, spurs, angles and variations, and other rights granted by existing laws and customs. This claim is further described as follows: The Monument of Location of this claim is approximately 4500 ft. southerly and 1500 ft. westerly of the NE corner of Section 14, Township 33 N, Range 51 E, Nevada Meridian, Eureka County, Nevada.

The adjoining claims are 1X 36 on the north; 1X 50 & 60 on the south; 1X 53 on the west; 1X 51 on the east.

The location work consisted of making & preparing maps as required in Nevada Revised Statutes 517:040. A notice of location is placed at Location Monument; Posts are placed at each corner at the center of each side line and the name of this lode and date of location, are placed on all posts.
