has located and do hereby locate 1500 linear feet in length, and 600 feet in width on the 1X 52

lode, vein, ledge or deposit (or placer ground), situated in above State, County or Mining District, and further described as follows: Commencing at a post marked SE corner located about 300' east from the monument of location, thence 750 feet in a Northerly

direction to a Eastside center post marked, thence 750 feet in a Northerly
