CORRECTION ASSIGNMENT OF OVERRIDING ROYALTY INTERESTS

KNOW ALL MEN BY THESE PRESENTS:

THAT, WHEREAS, by instrument entitled "Assignment of Overriding Royalty Interests", dated November 15, 1985, and recorded in the Office of the Clerk and Recorder on August 15, 1988, in Book 182 at Pages 183 to 192 of the records of Eureka County, Nevada, M. Peyton Bucy and Suzanne D. Bucy, Assignors, assigned an overriding royalty interest in and to oil and gas leases described on Exhibit "A" to William G. Odell, as Trustee of the Matt Peyton Bucy III Trust, Frank Dost Bucy Trust, Elisabeth Bucy Trust and Megan Bucy Trust, Assignees; and,

Odell, as Trustee of the Matt Peyton Bucy III Trust, Frank Dost Bucy Trust, Elisabeth Bucy Trust and Megan Bucy Trust, hereinafter referred to as Assignees, to correct the above Assignment to conform to the intent of the parties by correctly identifying the quantum of interest assigned.

NOW, THEREFORE, for and in consideration of Ten Dollars (\$10.00) in hand paid, each to the other, Assignors and Assignees hereby correct the Assignment of Overriding Royalty Interests dated November 15, 1985, in and to the oil and gas leases described on Exhibit "A", INSOFAR ONLY as follows:

The quantum of interest set forth in the first paragraph of said Assignment is hereby corrected to read as follows:


"One and One-Fourth Percent (1¼%) of eight-eighths overriding royalty"; and


The interest set forth opposite each Assignees' name is hereby corrected to read as follows:


