

AMENDED CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED hereby certifies that ATLAS PRECIOUS METALS INC., through its Agent and Representative, the undersigned, does hereby make and file this First Amended Location of the WI 119A Lode Mining Claim, on this 15th day of August 1988, and situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the NW (Quarter)Section(s) 10, Township 22 North, Range 50 East, Mt. Diablo P.M., and more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1:

Thence 600 feet in a S0°07'E direction to post No. 2, marked WI 119A -2  
 Thence 600 feet in a S2°W direction to post No. 3, marked WI 119A -3  
 Thence 30 feet in a N89°46'W direction to post No. 4, marked WI 119A -4  
 Thence 600 feet in a N2°E direction to post No. 5, marked WI 119A -5  
 Thence 600 feet in a N0°07'W direction to post No. 6, marked WI 119A -6  
 Thence 30 feet in a S89°46'E direction to post No. 1, marked WI 119A -1

the point of beginning, and all posts being 4" x4"x4' wood posts or 3" diameter.

The locator claims 1200 linear feet along the course of said vein or lode running 1180 feet in a S0°07'E direction and 20 feet in a N0°07'W direction from the point of location at which this amended location certificate is posted, with a width of 15 linear feet on each side of the center of the vein or lode along the entire length of said claim.

The general course of the vein or lode is N0°07'W and S2°W.

To tie this claim to the Public Survey, begin at the SE corner Section 14, Township 22 N., Range 50 E., Mt. Diablo P.M., and bear north, 10214 feet, and west, 8645 feet to the northeast corner of this claim.

The work of location consisted of making the maps as provided in NRS 517.040. Dated May 4th A.D., 1988, and filed in duplicate.

And, if the original Notice of Mining Location there is void, then this location shall be an original location and this Certificate an original Certificate.

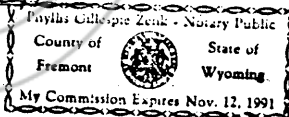
