NOTICE IS HEREBY GIVEN that Tonkin Springs Gold Mining Company, a Nevada corporation, hereby claims by right of discovery and location under and pursuant to the laws of the United States of America and of the State of Nevada the following described lode mining claim, and in making this claim and for the purposes of establishing its right thereto, hereby certifies and states as follows: The name and/or number of the claim and lode or vein is

CAMP No. 3. The name of the owner and locator is Tonkin Springs Gold Mining Company whose current mailing and post office address is 1501 Stout St., Ste. 1500, Denver, CO 80202-1500. The date of location is Sept 1, 1988. The number of linear feet claimed in the length along the course of the vein each way from the point of discovery, at which a discovery monument was erected and on which a notice of location was posted in accordance with applicable laws, is 20 feet NORTHerly and 1400 feet SOUTHerly, which is the general course of the lode or vein as near may be, and on the EASTerly side of the center of the vein 300 feet is claimed and on the WESTerly side of the center of the vein 300 feet is claimed.
