NOTICE IS HEREBY GIVEN, That the undersigned, having complied with the requirements of Chapter Six, Title thirty-two of the Revised Statutes of the United States, and the laws of the above State, and the local customs and regulations of said district,

has located and do hereby locate 1500 linear feet in length,  
and 600 feet in width on the MINIX 25

lode, vein, ledge or deposit (or placer ground), situated in above State, County or Mining District, and further described as follows: Commencing at a post marked SW corner located about 300' South from the monument of location thence 750 feet in a Easterly

direction to a post marked south side center, thence 750 feet in a Easterly

direction to a corner post marked SE cor., thence 600 feet in a Northerly

direction to a corner post marked NE Cor., thence 750 feet in a Westerly

direction to a post marked Northside center, thence 750 feet in a Westerly

direction to a corner post marked NW Cor., thence 600 feet in a Southerly

feet in a Easterly direction from Monument of location to the East

end line, and 50 feet in the opposite direction from discovery to the
