NOTICE IS HEREBY GIVEN, That the undersigned, having complied with the requirements of Chapter Six, Title thirty-two of the Revised Statutes of the United States, and the laws of the above State, and the local customs and regulations of said district,

has located and do hereby locate 1500 linear feet in length,

and 600 feet in width on the MINIX 12

lode, vein, ledge or deposit (or placer ground), situated in above State, County or Mining District, and further described as follows: Commencing at a post marked SE corner located about 300' southerly from the monument of Location, thence 750 feet in a Westerly

direction to a Southside center post marked, thence 750 feet in a Westerly
