The number of linear feet claimed in length along the course of the vein each way from the point of discovery, at which a discovery monument was erected and on which a notice of location was posted in accordance with applicable laws, is:

20 feet WEST erly, and 1480 feet EAST erly, which is the general course of the lode or vein as near may be, and on the NORTH erly side of the center of the vein 300 feet is claimed, and on the SOUTH erly side of the center of the vein 300 feet is claimed.

At each corner of the claim and at the center of each sideline, there is a monument in compliance with N.R.S. 517.030, so marked as to designate the claim name and corner identification.

The claim and its corners are more particularly described as follows:

From Corner No. 1, also known as NE corner of this claim, the SE corner of Section 36, T. 26N, R. 52 East of the Mt. Diablo P. M., if such corner exists, or a claim location marker constructed as specified in N.R.S. 517.040, if such corner does not exist, bears SOUTH a distance of 11,200 feet, thence EAST a distance of 6,500 feet.

Corner No. 1 is a 1" diam. 5' long white pipe labeled NE COR WHV 36

Corner No. 2 is a 1" diam. 5' long white pipe labeled SE COR WHV 36

Corner No. 3 is a 1" diam. 5' long white pipe labeled SW COR WHV 36

Corner No. 4 is a 1" diam. 5' long white pipe labeled NW COR WHV 36

The NORTH erly side center monument is a 1" diam. 5' long white pipe labeled N.S. CTR WHV 36 and lies midway between corners 1 and 4.

The SOUTH erly side center monument is a 1" diam. 5' long white pipe labeled S.S. CTR WHV 36 and lies midway between corners 2 and 3.
