CERTIFICATE OF LOCATION

LODE CLAIM

TO ALL WHOM IT MAY CONCERN:

The undersigned hereby certifies that he has caused to be located the BRR# 113 lode mining claim on the 11th day of August, 1988.

Said claim is located in the NE/4 of Sec. 12, Twp. 20 North, Range 50 East.  
Protracted SE/4 of Sec. , Twp. North, Range East.  
NW/4 of Sec. 7, Twp. 20 North, Range 51 East.  
SW/4 of Sec. , Twp. North, Range East.  
Mount Diablo Base and Meridian, Eureka County, Nevada.

To tie this claim to the Public Survey, begin at the Southwest corner of Section 31, Township 21 North, Range 51 East, Mount Diablo Meridian, thence 2400 feet South and 1800 feet East to the Northeast corner of this claim.

The general course of the lode or vein is East to West.

We (or I) claim 1500 linear feet along the course of the ledge, lode or vein, extending 10 feet from the location monument in a Easterly direction and 1490 feet in a Westerly direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial PVC Pipe monuments, firmly set in the ground and bearing applicable monument designation. The description of such claim is: Beginning at the Northeast Corner:

thence, South 600 feet to the Southeast corner.  
thence, West 750 feet to the South side center,  
thence, West 750 feet to the Southwest corner,  
thence, North 600 feet to the Northwest corner,  
thence, East 750 feet to the North side center,  
thence, East 750 feet to the Northeast corner, the point and place of beginning.
