The Court further finds that Decedent left a Last Will and Testament dated January 31, 1983, and that a copy of said Will has been admitted in evidence in this matter. Under the terms of Paragraph Fifth of said Will, all of the Decedent's property is left to his surviving wife, PATSY RUTH JOHNSON, the Petitioner herein.
